## **News from Europe**

#### State of Health in the EU

The *State of Health in the EU* initiative is a collaboration of the European Commission, the OECD, and the European Observatory on Health Systems and Policies. The *State of Health in the EU* initiative aims to strengthen country-specific and EU-wide knowledge on health and to support member states in evidence-based policy making.

It includes (1) a new edition of the *Health at a Glance: Europe* report (see also the news item below), (2) *Country Health Profiles* for each member state, a (3) *Commission Paper* that links the results of the report and the profiles to the EU agenda and that emphasizes cross-cutting policy implications, and (4) the possibility for member states to discuss the results and potential implications and request for voluntary exchange with representatives of the EC, OECD and the European Observatory on Health Systems and Policies (see figure below).



#### Release of Health at a Glance: Europe 2016 – State of Health in the EU Cycle (23 November)

The new edition of *Health at a Glance: Europe 2016 – State of Health in the EU Cycle* will be released on 23 November 2016 during a press conference in Brussels with EC Commissioner Vytenis Andriukaitis and OECD Secretary-General Angel Gurría. This new edition, which continues to be based largely on the ECHI indicators, contains a number of new features. Two thematic chapters analyse: 1) the links between population health and labour market outcomes; and 2) the challenge of strengthening primary care systems in European countries. In addition, a new chapter on the resilience, efficiency and sustainability of health systems in Europe aligns the content of this publication more closely with the 2014 European Commission Communication



on effective, accessible and resilient health systems. This publication is the result of a renewed collaboration between the OECD and the EC under the broader "State of Health in the EU" cycle which is designed to support EU member states in their evidence-based policy making.

#### **BRIDGE Health**

The BRIDGE Health project (BRidging Information and Data Generation for Evidence-based Health policy and research), that aims to prepare the transition towards a sustainable and integrated EU health information system, was introduced by Petronille Bogaert and Herman van Oyen in the past PHMR section newsletter. In the meantime the project has delivered a Concept Paper which will be circulated in December 2016. The Concept Paper presents the BRIDGE Health analysis of the current situation and the possibilities for creating an organisational entity that could take up some of the support tasks that come with the need for strengthening the EU health information system to support research and evidence-based policy for the EU and Member States. Using multi-criteria analysis, the advantages, disadvantages and short-term feasibility were investigated.

This analysis concluded that a European Research Infrastructure Consortium on Health Information for Research and Evidence-based Policy (HIREP-ERIC) is at this time the most feasible option. This to set important steps in the right direction and fulfil some of the most important criteria for an effective organisation around the scientific underpinning of health policy and research by new and better evidence from more and better comparable data.

BRIDGE Health is working with and within DG SANTÉ's Drafting Group of the ERIC on Health Information on the technical and scientific description of the HIREP-ERIC and the legal statutes. Some of the main results of the HIREP-ERIC will be presented on **20 April 2017**. BRIDGE Health is organising jointly with the Belgian Federal Public Service Health, Food Chain Safety and Environment a one day strategic policy meeting entitled "The Strategy for Health Information of the European Union". #### **Update: European Health Information Survey**

Eurostat has now disseminated six datasets based on European Health Interview (not Health Information!) Survey (EHIS) wave 2 data (wave 2 was conducted between 2013 and 2015). Please note that this first dissemination covers only 26 Member States as Italy and Ireland will provide the micro-data file later on. This is the first step in the dissemination of EHIS wave 2 data. By the end of the current year all other datasets as well as data from the two currently missing Member States, Iceland, Norway (both countries will also soon transmit the data file to Eurostat) and Turkey (file already available in Eurostat but not yet validated) will be online. The previous datasets with EHIS wave 1 data (wave 1 conducted between 2006 and 2009) are now placed under 'historical data' and will be merged with EHIS wave 2 datasets later on (whenever possible).

#### European Health Forum Gastein (2016) - Workshop: Capturing Change

A workshop organized by WHO Europe at the recent European Health Forum Gastein brought together a high-level panel to discuss the challenges and potential solutions for health information in Europe today. The panel included the minister of health of Malta, the Rt Hon Christopher Fearne, the deputy director of the Federal Research Institute of the Russian Federation, Dr Anna Korotkova, the managing director of EuroHealthNet, Ms Caroline Costongs, the Senior



Project Lead on Health Indicators of OECD, Prof Niek Klazinga and Dr Claudia Stein, Director of the Division of Information, Evidence, Research and Innovation at the WHO Regional Office for Europe. All panel members and many participants stressed the importance of networks – national, regional and sub-regional – as an important catalyst for strengthening coordination in the area of health information. They called for increased harmonization of health information in Europe and stressed the importance of working towards a single integrated health information system for the whole WHO European Region. They also called on WHO, OECD and the European Commission to work more closely together, using the European Health Information Initiative as the platform for this collaboration.




